## FREQUENTLY ASKED QUESTIONS

#### Who is GFI Group?

GFI Group Inc. (NYSE: "GFIG") is a leading provider of wholesale brokerage services, clearing services, electronic execution and trading support products for global financial markets. GFI Group Inc. provides brokerage services, market data, trading platform and analytics software products to institutional clients in markets for a range of fixed income, financial, equity and commodity instruments.

#### What is Charity Day?

Charity Day is held every year on 11 September, or the closest working day to it, in memory of the 658 colleagues lost in the World Trade Centre attacks in 2001. It is a day on which we commemorate those no longer with us by raising funds for charitable works worldwide.

#### How do we raise money?

All GFI revenues worldwide on Charity Day, together with our affiliates BGC Partners, RP Martin and Sunrise Brokers, are donated to selected charities, as are all broker commissions for the day.

#### How does the day work in the UK?

On Charity Day celebrity ambassadors join us on behalf of charities, helping to bring energy and excitement to the day. They visit the trading floors to meet with the 1,000 brokers and are invited to take part in real trades with clients over the phone, guided at all times by a GFI broker.

Charity Day runs from 08.00-16.00, during which each charity is given an allocated time to visit.

#### What is expected of the celebrity ambassadors?

We would hope that each selected charity bring between 2-3 celebrity ambassadors on the day. We request that each celebrity ambassador:

- spends I- 2 hours with us
- speaks on the phone with clients and takes part in trades (guided every step of the way by our brokers)
- takes part in interviews with selected media present on the day (if they are happy to do so)
- takes part in internal interviews (please see our Charity Day videos for examples)
- uses their own social media platforms to promote the Charity they are supporting as well as GFI Charity Day in the run up to and on the day itself by posting, re-posting, following and sharing etc.

#### What about the non-celebrity attendees?

The GFI Charity Day is a fun day. In addition to your celebrity representatives you are welcome to bring along a small group (of no more than three people) from your charity. We also encourage charities with young beneficiaries to invite 2-3 families to join us for an action packed day. We request each charity to attend on the day for approximately 2-3 hours.

#### How are the donations calculated?

The Charity Day donations are allocated by GFI's senior management. Many factors are taken into account from the annual revenue of the charity to the way in which the charity and their celebrity ambassadors engage with the day. It is GFI's aim to distribute the Charity Day donations within 12 months of each Charity Day by way of either cash or stock transfer.
